## COVID-19 PREPARATIONS

Public Risk Management Association is committed to the safety and well-being of its conference attendees, exhibitors, staff and guests. We are closely monitoring government mandates and policy changes, Centers for Disease Control (CDC) guidelines and public health advancements. As information pertaining to the virus continues to develop, we will adjust our approach as needed and keep you up to date with new developments to ensure a coordinated effort and a safe environment for all PRIMA conference visitors.

### ENTRY REQUIREMENTS

PRIMA's commitment to protecting and preserving public health, every individual who participates in #PRIMA22 in San Antonio will be required to:

#### **Provide proof that you are fully vaccinated against COVID-19.**

- To be considered "fully vaccinated" you must receive your final vaccine dose 14 days prior to your entry date.
- Vaccination documentation will be requested electronically six weeks prior to the start of the conference by uploading an image of your documentation using our third party vendor.
- Copies of vaccination documentation uploaded in advance are NOT stored. Once verified, the images are deleted.
- PRIMA will NOT have access to your health information.

OR

#### **Provide proof you obtained a negative COVID-19 test result within 72-hours of arriving at registration to pick up your badge.**

- For those who opt for the COVID-19 test within 72 hours of the start of the event, we encourage you to test before you travel. However, on-site COVID-19 testing will be available at the attendee's expense. A fee will be charged by PRIMA's testing vendor should you choose to utilize this service.

### HEALTH & SAFETY BEST PRACTICES

Show management will implement the following best practices to help mitigate the spread of COVID-19:

- Requesting that all staff and attendees stay home if they are sick or have been exposed to someone who is sick.
- **Face Coverings:** To date, face mask are not mandatory in the city of San Antonio, TX. However, PRIMA highly encourages you to wear a face mask while in public indoor settings during the conference activities.
- **Hand Sanitizer Stations:** We will have hand sanitizing systems easily accessible to everyone throughout the event.

- **Food and Beverage:** Meals and networking events will be tailored with your safety in mind, so you can relax and enjoy the experience.
- If you become ill during the conference, please remain in your hotel room and contact the hotel so that you can follow their COVID-19 protocol.

## ON-SITE TESTING

PRIMA will offer COVID-19 tests as a convenience for participants that wish to or need to be tested prior to returning home.

An on-site Testing Suite beginning Sunday, June 5, through Wednesday, June 8 will be available.

Monday, June 6 | 8:00am – 12:00pm

Tuesday, June 7 | 8:00am – 12:00pm

Wednesday, June 8 | 8:00am – 12:00pm

Testing will be available at cost, payable by credit card at time of testing.

Test results will be available within 15-20 minutes of your testing appointment.
